- 5. SUN PROTECTION:** NEVER LEAVE YOUR PET IN DIRECT SUNLIGHT FOR LONG PERIODS. ALWAYS USE PROTECTIVE GEAR, SUCH AS SUNSCREEN, TO PROTECT YOUR PET'S SKIN.
