It commemorates the Mexican army's unlikely victory over French forces at the **Battle of Puebla on May 5, 1862**, led by General Ignacio Zaragoza. It is not Mexican Independence Day (Sept. 16), but a celebration of resilience, national pride, and unity against foreign intervention, largely popularized in the U.S.



Mother's Day:

Sunday, May 10 Established in the U.S. in 1914 by Anna Jarvis to honor her own mother, it has become a global celebration of motherhood, often featuring traditions like breakfast in bed and handmade items.



Memorial Day:

Monday, May 25 is observed a federal holiday in the United States, it honors military personnel who died in service, featuring community parades, wreath-laying ceremonies, and a national moment of silence at 3 p.m. local time.

Oklahoma's Updated Move Over Law

The law requires drivers to slow down and, when possible, move over to the next lane when approaching a vehicle with flashing lights. Failure to do so will now result in steeper penalties than before.

Oklahoma also bans texting while driving for all drivers and, as of **November 1, 2025**, prohibits holding a cell phone in active school and work zones. Only hands-free use is allowed in these critical areas.

Penalties for texting include a **\$100 fine**, with higher fines for repeat offenses. Violations in school or work zones may result in increased fines and potential license suspension if an accident occurs.

Commercial drivers face stricter rules, with hand-held phone calls banned statewide.
